- Proof of registration or letter of acceptance for 2026
- Proof of residence
- Any other relevant supporting documents (e.g., community letters, curriculum vitae of leadership roles)

**Important:** Use Google Chrome when applying to ensure smooth document uploads.

### How to apply — step-by-step

1. Gather the required documents and ensure all certified copies are dated within the last 3 months.
2. Prepare a clear, professional CV that highlights academic achievements, relevant projects, and any work or leadership experience.
3. Ensure your latest academic record meets the minimum average of 60%.
4. Follow the official Seriti application link and complete the online application form. (Replace any placeholder links with the official Seriti application page if provided.)
5. Upload your documents as a single PDF or as multiple attachments as instructed.
6. Submit before **22 December 2025**. Late applications are generally not considered.

### Tips for a strong application

- Start early and check academic records carefully. Missing or late documents disqualify many applicants.
- Have your ID and proof of residence certified and dated within three months prior to application.

- Write a concise personal statement (if required) explaining why you chose your field and how a Seriti bursary would help your career goals.
- If you are from a local Seriti community, include supporting documents showing your ties to the area.

### FAQs (Frequently Asked Questions)

#### **Q1: What is the closing date for the Seriti Bursary 2026?**

A: The application closing date is **22 December 2025**. Ensure your application and certified documents are submitted before this date.

#### **Q2: Can first-year students apply?**

A: Yes — but only for **Geology** or **Environmental** disciplines.

A: Certified copies of ID, qualifications, and proof of residence must be certified within the last three months.
